## DAVID WORLOCK APPOINTED AS SPECIALIST ADVISOR TO UK PARLIAMENTARY SCIENCE AND TECHNOLOGY COMITTEE INQUIRY

David Worlock, Chairman of Electronic Publishing Services Ltd (EPS), has been appointed as special advisor to the House of Commons' Science and Technology Committee inquiry into scientific publications.

The Committee, chaired by Ian Gibson MP, will be looking at access to journals within the scientific community, with particular reference to price and availability. It will be asking what measures are being taken in government, the publishing industry and academic institutions to ensure that researchers, teachers and students have access to the publications they need in order to carry out their work effectively. The inquiry will also examine the impact that the current trend towards e-publishing may have on the integrity of journals and the scientific process. Oral evidence sessions will begin in March.

Announcing the inquiry in December 2003, Ian Gibson said "Journals are at the heart of the scientific process. Researchers, teachers and students must have easy access to scientific publications at a fair price. Scientific journals need to maintain their credibility and integrity as they move into the age of e-publication. The Committee will have some very tough questions for publishers, libraries and government on these issues."

David Worlock is the perfect choice to advise the Committee. He has worked in publishing ever since leaving the University of Cambridge with a history degree in 1967 and has consistently taken a keen interest in innovative delivery channels and their implications for publishing business models. After joining Thomson Corporation as a trainee, he worked in educational and academic publishing before managing Thomson's school-based publishing as Group Executive Publisher in the late 1970s. From 1980 to 1985 he was CEO of the pioneer development of EUROLEX, the UK's first online service for lawyers.

After EUROLEX was acquired by Reed, in 1985, David Worlock founded Electronic Publishing Services Ltd (EPS) which has become the leading UK-based consultancy concentrating on electronic content delivery. Since then, EPS has undertaken projects focusing on a wide variety of content types – from text to audio-visual, from online to wireless, from narrowband to broadband – and on a range of sectors within the global publishing marketplace - including Scientific, Technical and Medical, Education, Professional, Business-to-Business, National and Regional press and Public Sector. I am sure that the recent experience of EPS in setting up the EPS Market Monitor research programme to provide objective quantitative benchmarking for publishing marketplaces, commencing with scientific technical and medical publishing, will be invaluable for this task."

David is also Chairman of the Digital Content Forum, which forms a two-way conduit between the representative organizations for 32 UK information industry organizations in their dialogue with government on digital content issues. Other public appointments include his roles as a member of the Advisory Panel on Crown Copyright (Cabinet Office) and as the independent commercial representative on the Content Advisory Board (Department for Education and Skills). Previously, he had served as chairman of the European Information Industry Association, and then of the Information and Communication Industry Association.

The Committee is inviting written evidence on the following points by Thursday 12th February 2004:

- What impact do publishers' current policies on pricing and provision of scientific journals, particularly "big deal schemes", have on libraries and the teaching and research communities they serve?
- What action should Government, academic institutions and publishers be taking to promote a competitive market in scientific publications?
- What are the consequences of increasing numbers of open-access journals, for example for the operation of the Research Assessment Exercise and other selection processes? Should the Government support such a trend and, if so, how?
- How effectively are the Legal Deposit Libraries making available non-print scientific publications to the research community, and what steps should they be taking in this respect?
- What impact will trends in academic journal publishing have on the risks of scientific fraud and malpractice?
