1. Use of Restricted Future Cash:

- a. Key information to extract from the Cash position summary:
 - i. Overall: If all expenses incurred to date were paid, there would be a cash balance of \$163,955 for the organization as a whole.
 - ii. Operations:
 - 1. Current position is strong with \$203,031 positive liquidity
 - 2. To maintain positive liquidity in 12 months \$159,248 should be repaid to restricted cash. (362,279 203,032 = 159,248)
 - 3. To maintain positive liquidity in more than 12 months, \$355,248 should be repaid to restricted cash.
 - iii. Sakai 3-OAE:
 - 1. As of April 2011, invoices have been issued which covers projected expenses for the remainder of the project. The Sakai foundation general fund has been repaid the balance of \$49,336 in March.
 - iv. Conferences:

\$6K has been received in advance for specific costs; however Concentra has been paid \$11,221. This means that the *Sakai General fund has contributed \$5,221* (6,000-11,221) to the conference as of March 2011.

v. Pre-Paid Memberships:

All cash collected for prepaid memberships has been extended to current operating use.

2. Use of Estimates:

Certain estimates have been made for expenses not yet invoiced. It is helpful to communicate with vendors, a desire to receive invoices in the first week of the month following services rendered.

3. 2011 Budget (page 5)

- a. Approved budget is now presented compared to actual year-to-date figures.
- b. The S3-OAE budget has also been included to produce an organization wide budget
 - i. There is currently a significant projected surplus, awaiting additional information from project manager regarding possible additional costs.
- c. Assumptions (as previously stated):
 - i. Revenue based on current membership growth neutral
 - ii. All previously accepted staffing reductions effective January 1, 2011
 - iii. Travel cost based on 3 year average
 - iv. Other expenses based on previous year and known adjustments
 - v. Conference \$25,000 contingency deficit
 - vi. It is expected that the Sakai 3/OAE project will be cost neutral to the organization.

4. 2011 Cash Projection – Sakai General Fund (page 6)

- a. Cash projection provided separately for S3-OAE
- b. The change in cash for 2011 is projected to require approximately \$76K additional collections in order to maintain the current cash balance.
- c. Memberships invoiced have exceeded expectations by: +23,833
- d. Projected cash deposits have increased by: +32,600
- e. Collections have been faster than the projected 60 days: 30 days
- f. Expenses have been less than projected by: -2,044
- g. Assumptions (as previously stated):
 - i. Membership invoices are expected to collect in 90 days, on average.
 - ii. Invoice dates are based on prior year memberships and invoicing schedule.
 - iii. 2010 accounts receivables are expected to collect in full in 1st Quarter 2011 in order to cover 1st Quarter expenses.
 - iv. It is anticipated that the receipt of University of Michigan invoices will coincide with the repayment of the balance receivable from S3/OAE
