## Introduction

The Common Core of Data (CCD) is an annual universe collection of public elementary and secondary education data that is administered by the National Center for Education Statistics (NCES) and its data collection agent, the U.S. Census Bureau. Data for the CCD surveys are provided by state education agencies (SEAs). This report presents findings on the numbers of public school students, staff, and high school completers in the United States and other jurisdictions<sup>1</sup> in school year 2005–06,<sup>2</sup> using data from the State Nonfiscal Survey of Public Elementary/Secondary Education of the CCD survey system.

The State Nonfiscal Survey of Public Elementary/Secondary Education presents counts of students by grade and by grade and race/ethnicity. It also presents the numbers of students who received a high school diploma or other high school completion credential during the previous school year. The survey also presents counts of full-time-equivalent (FTE)<sup>3</sup> teachers, aides, support staff, and administrators in public schools and school districts.

SEAs participate in the CCD voluntarily, following standard definitions for the data items they report. In some cases, SEAs may be unable to report a data item, or may not be able to report a data item in exact accordance with a CCD definition. When states were unable to report key data items, values for these items were collected from alternate sources, imputed, or adjusted. Missing data were imported from a public website for the Bureau of Indian Education in the 2005–06 CCD. Please see Appendix A: Methodology and Technical Notes in this report for a detailed discussion of collections from alternate sources, imputations, and adjustments.

While tables include data for all of the CCD respondents, the discussion in the text is limited to the 50 states and the District of Columbia.

More information about the survey content and methodology can be found in appendix A. Appendix B is a glossary of key CCD terms used in this report.

# **Selected Findings: School Year 2005–06**

- Public elementary and secondary schools had 49.1 million students in membership in school year 2005–06 (table 1). This was an increase of 1 percent from the 48.8 million students in membership in school year 2004–05 (Sable and Hill 2006, table 1).
- In the 2005–06 school year, 34.3 million students (69.9 percent of all students) were enrolled in prekindergarten through grade 8 and ungraded classes; 14.8 million students (30.1 percent of all students) were enrolled in grades 9–12 (derived from table 1).
- When examining students for whom race/ethnicity was reported in the 2005-06 school year, 4 57.1 percent were White, non-Hispanic; 19.8 percent were Hispanic; 17.2 percent were Black, non-Hispanic; 4.6 percent were Asian/Pacific Islander; and 1.2 percent were American Indian/Alaska Native (derived from table 2). The percentage of students who were White, non-Hispanic decreased from 57.9 percent for White, non-Hispanic students in school year 2004–05 (Sable and Hill 2006, derived from table 3).
- Almost 2.8 million students were awarded a high school diploma in the 2004–05 school year and following summer (table 3). An additional 54,012 received another high school completion credential.5
- The averaged freshman graduation rate (AFGR), an estimate of the percentage of high school students who graduate on time (i.e., within 4 years), was 74.7 in school year 2004–05 (table 4).<sup>6</sup> The AFGR ranged from 85.1 percent or more in Iowa, Minnesota, Nebraska, New Jersey, North Dakota, Vermont, and Wisconsin to 64.1 percent or less in Alaska, Georgia, Louisiana, Mississippi, Nevada, and South Carolina.
- In school year 2005–06, public elementary and secondary schools and local education agencies employed a total of 6.1 million FTE staff (table 5). This was an increase of 1 percent from the number of FTE staff employed in school year 2004–05 (Sable and Hill 2006, table 4).
- Of the FTE staff in the 2005–06 school year, 51.2 percent were teachers, 14.7 percent were instructional aides, instructional coordinators and supervisors, guidance counselors, or librarians, 23.2 percent were student and other support staff, and 10.8 percent were school administrators, school district administrators, and administrative support staff (derived from table 5).
- The average student/teacher ratio in public schools in school year 2005–06 was 15.7 (i.e., there were about 16 students for every FTE teacher employed) (table 6). The ratio ranged from a high of 22.1 in Utah to a low of 10.7 in Rhode Island. The average elementary student/teacher ratio was 19.4, while the average secondary student/teacher ratio was 12.9.

# **Appendix A: Methodology and Technical Notes**

Common Core of Data survey system. The State Nonfiscal Survey of Public Elementary/Secondary Education, the Local Education Agency Universe Survey, and the Public Elementary/Secondary School Universe Survey are the nonfiscal components of the Common Core of Data (CCD) survey system, while the School District Finance Survey and the National Public Education Financial Survey are the fiscal components. These surveys are reported annually by state education agencies (SEAs) through the efforts of state CCD coordinators. Participation in the CCD is voluntary.

Data for CCD surveys are collected from SEAs through an online reporting system. They are then processed, edited, and verified by the U.S. Census Bureau, the National Center for Education Statistics (NCES), and the Education Statistics Services Institute (ESSI) of the American Institutes for Research (AIR). The 2005–06 school year CCD collection opened on March 15, 2006 and closed on October 1, 2006.

**Data quality.** Staff at NCES, the Census Bureau, and ESSI collaborate to edit all CCD data submissions and ask state CCD coordinators to correct or confirm any numbers that appear out of range when compared with other states' data or with the state's reports in previous years. If no explanation for anomalous data is provided by the state, NCES will change the data value. For example, NCES will replace a reported total with the sum of detail in cases where the sum of detail exceeds a reported total. NCES will also change a value to "not available" if data values are not plausible (e.g., if the number of high school diploma recipients reported by a state is substantially greater than the number of 12<sup>th</sup> grade students in the previous year, and the state cannot explain this discrepancy, NCES will set the current year value for high school diploma recipients to not available.)

Missing data. Not all states collect and report all of the data items requested in CCD surveys. NCES attempts to correct missing data first by drawing on other sources. For example, if the number of teachers was missing in the State Nonfiscal Survey, but reported in the Local Education Agency Survey, the state-level number would be summed from the state's local education agencies. In some cases, a state is unable to report data during the collection period, but publishes them later, through a written report or website. NCES imports data from these other published sources to correct missing items. When this is done, file documentation identifies all instances in which data were summed or imported from other CCD surveys or outside sources. These procedures to correct for missing data are used for any CCD data item and for all three CCD nonfiscal surveys

If missing data cannot be corrected by summing from other CCD surveys or using alternate external sources, NCES imputes some missing items (i.e., replaces a nonresponse with a plausible value) in the State Nonfiscal Survey. (See below for information on imputation procedures.) Data are not imputed in the Public Elementary/Secondary School Universe Survey or the Local Education Agency Universe Survey.

If information is missing for some but no more than 15 percent of states across the 50 states and District of Columbia, NCES calculates totals and identifies them as "reporting states" totals (rather than totals for the United States). Precise information about the extent of missing data is included in the documentation for the State Nonfiscal Survey of Public Elementary/Secondary Education, which can be accessed at <a href="http://nces.ed.gov/ccd/stnfis.asp">http://nces.ed.gov/ccd/stnfis.asp</a>.

*Imputed and adjusted data.* NCES imputes and adjusts some reported values in the State Nonfiscal Survey of Public Elementary/Secondary Education to create data files that more accurately reflect

student and staff counts and to improve comparability among states. Imputations and adjustments are performed on data from the 50 states and District of Columbia only. Although no imputations are made to data in the high school graduate or other high school completer categories, the numbers in these categories are modified to prevent identification of any individual. No adjustments or imputations are performed on race/ethnicity data for any state.

- *Imputations* provide plausible values in cases in which the missing value is not reported, indicating that subtotals for the category are underreported. An imputation assigns a value to the missing item, and subtotals containing this item increase by the amount of the imputation.
- Adjustments are corrections in cases in which a value reported for one item contains a value for one or
  more additional items not reported elsewhere. For example, a state may not differentiate between
  kindergarten teachers and prekindergarten teachers, reporting "missing" for prekindergarten teachers
  and a value representing the count of staff for both categories as kindergarten teachers. NCES adjusts
  these two responses by reducing the amount reported for kindergarten teachers and adding that amount
  to prekindergarten teachers.

Values are imputed or adjusted for some missing items in the State Nonfiscal Survey of Public Elementary/Secondary Education. All imputed or adjusted values in the tables are footnoted, and such values are never used in the imputation or adjustment of another value. Totals and subtotals in tables are footnoted if one or more items in the total or subtotal are imputed or adjusted.

**Totals.** Totals reported in the tables are limited to the 50 states and the District of Columbia. They do not include data from the Bureau of Indian Education, Department of Defense dependents schools (overseas and domestic), Puerto Rico, or the other jurisdictions of American Samoa, Guam, the Commonwealth of the Northern Mariana Islands, or the U.S. Virgin Islands. In cases where not all but at least 85 percent of the 50 states and the District of Columbia provide a response for a data item, a "reporting states" total is presented. See "Missing data" (above) for more information.

Agreement across survey levels. Some students receive a public education outside a local school district or school (for example, they may attend a state-operated residential school). Some students in a regular school district may not be served by a school. Hospital or homebound students, for example, may be reported in the membership for a regular school district but not in any of the district's schools. The numbers of students and staff shown in the tables for any CCD First Look report are derived from the survey represented in that report. Therefore, the numbers may differ across reports. The numbers reported in the State Nonfiscal Survey of Public Elementary/Secondary Education are considered the official statistics for a state.

*Staff counts.* All staff counts (including teachers) are reported in full-time-equivalent (FTE) units. This is the amount of time required to perform an assignment stated as a proportion of a full-time position. It is computed by dividing the amount of time an individual is employed by the time normally required for a full-time position.

State agencies vary in their staff data collection and reporting systems, with resulting variations across states. Several states collapse two or more categories of staff into one. In these cases, for the state nonfiscal data only, NCES disaggregates this number by distributing the reported number of staff across the several categories based on the average distribution of these staff in the reporting states. Staff counts in the local education agency and school surveys are not disaggregated and redistributed.

*High school completers.* The types of high school completion credentials available to students vary by state policy. For example, in some states the only type of completion available is a regular diploma; in others, a variety of completion credentials are awarded, from a regular diploma to a certificate of attendance. For this reason, caution should be used when comparing state totals for diploma recipients.

The category of other high school completers includes certificates of attendance or completion. It does not include high school equivalency credentials such as those based on the General Education Development (GED) test. "Not applicable" is accepted as a valid response for other high school completers, as some states do not offer this credential.

Confidentiality protection of high school completer data. Under some conditions, it might be possible to identify a student who was enrolled in the 12<sup>th</sup> grade and who failed to receive a regular diploma at the end of that school year. For example, if a school district had only ten 12<sup>th</sup>-grade White, non-Hispanic students in 2004–05 and no White, non-Hispanic diploma recipients, it might be assumed that all of these students failed to graduate. (This would have to be an assumption, because the CCD cannot distinguish students who fail to graduate from those who transfer out of a school district or state.)

In order to prevent the identification of any 12<sup>th</sup>-grade student who fails to receive a regular diploma, high school completion data are modified, either by changing some completion data to missing or by increasing the reported number of diploma recipients. These changes result in a minimal loss of data.

Averaged freshman graduation rate (AFGR). The AFGR provides an estimate of the percentage of high school students who graduate on time. The rate uses averaged student enrollment data (to estimate the size of an incoming freshman class) and aggregate counts of the number of diplomas awarded 4 years later. The incoming freshman class size is estimated by summing the enrollment in 8<sup>th</sup> grade in one year, 9<sup>th</sup> grade in the next year, and 10<sup>th</sup> grade in the year after and then dividing by 3. The averaging is intended to account for prior-year retentions in the 9<sup>th</sup> grade.

## **Appendix B: Common Core of Data Glossary**

American Indian/Alaska Native—A person having origins in any of the original peoples of North and South America (including Central America) and who maintains cultural identification through tribal affiliation or community recognition.

Asian/Pacific Islander—A person having origins in any of the original peoples of the Far East, Southeast Asia, the Indian subcontinent, or the Pacific Islands. This area includes, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, Thailand, Vietnam, Guam, the Philippine Islands, Samoa, and other Pacific Islands.

**averaged freshman graduation rate (AFGR)**—An estimate of the percentage of an entering high school class that graduates on time. See Appendix A: Methodology and Technical Notes for more information.

**Black**—A person having origins in any of the Black racial groups of Africa. Terms such as Haitian or Negro can be used in addition to Black or African American.

**Bureau of Indian Education schools and districts**—A school or district that is directly funded by the Bureau of Indian Education (formerly Bureau of Indian Affairs), U.S. Department of the Interior.

**diploma, high school**—A formal document certifying the successful completion of a secondary school program prescribed by the state education agency (SEA) or other appropriate body.

**elementary/secondary education**—Programs providing instruction, or assisting in providing instruction, for students in prekindergarten, kindergarten, grades 1 through 12, and ungraded programs.

**full-time equivalent (FTE)**—The amount of time required to perform an assignment stated as a proportion of a full-time position and computed by dividing the amount of time employed by the time normally required for a full-time position.

**guidance counselors**—Professional staff assigned specific duties and school time for counseling students and parents, addressing learning problems, evaluating student abilities, and assisting students in career and personal development.

**high school completers**—Students who completed the course of public elementary and secondary education offered by the school district and who received a high school diploma, or who met other requirements of completion as defined by state law or policy, during the period October 2004 through September 2005 (for school year 2004–05 completers). Does not include high school equivalency recipients.

**Hispanic**—A person of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish culture or origin, regardless of race.

**instructional aides**—Staff members assigned to assist a teacher with routine activities associated with teaching (i.e., activities requiring minor decisions regarding students), such as monitoring, conducting rote exercises, operating equipment, and clerking. Includes only paid staff (i.e., excludes volunteer aides).

**instructional coordinators and supervisors**—Persons who supervise instructional programs at the school district or subdistrict level, including educational television staff; coordinators and supervisors of audiovisual services; curriculum coordinators and in-service training staff; Title I coordinators and home economics supervisors; and staff engaged in the development of computer-assisted instruction. School-based department chairpersons are excluded.

instructional support staff—Instructional coordinators and supervisors and instructional aides.

**kindergarten**—A group or class that is part of a public school program and is taught during the year preceding first grade.

**librarians**—Professional staff members or supervisors assigned specific duties and school time for professional library services activities. These include selecting, acquiring, preparing, cataloging, and circulating books and other printed materials; planning the use of the library by students, teachers, and instructional staff; and guiding individuals in the use of library books and material maintained separately or as part of an instructional materials center.

**library/media staff**—Professional staff members who are assigned specific duties and school time for professional library and media service activities. Includes library/media specialists and support staff.

**local education agencies (LEAs)**—Those agencies at the local level whose primary responsibility is to operate public schools or to contract for public school services.

**LEA administrative support staff**—Staff members who provide direct support to LEA and school administrators, including secretarial or other clerical staff, and persons whose activities are concerned with support of the teaching and administrative duties of the office of the principal, department chairpersons, and central office administrators.

**other high school completer**—An individual who has received a certificate of attendance or other certificate of completion in lieu of a diploma during the previous school year and subsequent summer school.

**other support staff**—Staff who serve in a support capacity and who are not included in the categories of central office administrative support, library support, student support, or school administrative support (e.g., data processing staff; bus drivers; and health, building, equipment maintenance, security, and cafeteria workers).

**prekindergarten student**—A student who is enrolled in a group or class that is part of a public school program taught during the year or years preceding kindergarten, excluding Head Start students, unless Head Start is part of an authorized public education program of an LEA.

**public school**—An institution that provides education services and has one or more grade groups (prekindergarten through grade 12) or is ungraded, has one or more teachers to give instruction, is located in one or more buildings or sites, has an assigned administrator, receives public funds as primary support, and is operated by an education agency.

school administrators—Staff members whose activities are concerned with directing and managing the operation of a particular school. These include principals, assistant principals, and other assistants; and persons who supervise school operations, assign duties to staff members, supervise and maintain the records of the school, and coordinate school instructional activities with those of the education agency, including department chairpersons.

**student membership**—Annual headcount of students enrolled in school on October 1 or the school day closest to that date. In any given year, some small schools will not have any students.

**teacher**—A professional school staff member who instructs students in prekindergarten, kindergarten, grades 1 through 12, or ungraded classes and maintains daily student attendance records.

**ungraded**—A class that is not organized on the basis of grade grouping and has no standard grade designation. This includes regular classes that have no grade designations and special classes for exceptional students that have no grade designations. Such a class is likely to contain students of different ages who, frequently, are identified according to level of performance in one or more areas of instruction rather than according to grade level or age level.

**White**—A person having origins in any of the original peoples of Europe, North Africa, or the Middle East.
