# Executive Summary

## Introduction

This report presents detailed tabulations of student enrollment in postsecondary education institutions in the 50 states and the District of Columbia for fall 1997. It focuses primarily on degree granting institutions that are eligible for Title IV federal financial aid although summary data are also presented for non-degree granting eligible institutions<sup>1</sup>. Data for this report are taken from the Fall Enrollment survey, a component of the Integrated Postsecondary Education Data System (IPEDS) of the U.S. Department of Education's National Center for Education Statistics (NCES).

This is the second year that NCES has used Title IV eligibility and degree-granting status to operationally define a higher education institution. Prior to 1996 higher education institutions were defined as postsecondary institutions that were accredited at the college level by an agency recognized by the Secretary, U.S. Department of Education (ED). This change from reporting on higher education institutions as defined by accreditation status to reporting them defined by Title IV eligibility and degree-granting status was necessary because the ED no longer distinguishes among institutions based upon accreditation status. Thus, it is no longer possible for NCES to obtain updated lists of "higher education" institutions as defined in previous reports. In lieu of this designation, NCES has identified subsets of postsecondary institutions on the basis of whether or not they are eligible to participate in Title IV federal financial aid programs because Title IV eligibility has implications for reporting and is of particular policy interest.<sup>2</sup> Institutions are further subdivided by whether or not they grant degrees, information that is available directly from IPEDS data.<sup>3</sup>

<sup>1</sup> In the remainder of the report institutions that are eligible for Title IV federal financial aid will be designated simply as "eligible".

<sup>2</sup> Title IV eligibility is based on lists of eligible institutions maintained by ED's Office of Postsecondary Education (OPE).

<sup>3</sup> In 1995, the Title IV eligible, degree-granting universe included approximately 5 percent more institutions than were included in the universe of institutions that were accredited at the college level. Most of the institutions that were added to the new reporting universe were private, for-profit institutions with relatively small student enrollments. Therefore, it is estimated that the difference in the total enrollment of the Title IV eligible, degree-granting universe is approximately 0.1 percent larger than the former "accredited" universe. ## Characteristics of Enrolled Students

In the fall of 1997, 14.9 million students were enrolled in the 6,252 postsecondary institutions that were eligible to participate in Title IV federal financial aid programs. Of these, 97.3 percent were enrolled in institutions that awarded at least an associate's degree (table A). Over three-fourths of all students were enrolled in public institutions, of which, 98.5 percent attended degree-granting institutions and 1.5 percent were enrolled in non-degree granting institutions.

About 21 percent of students in eligible degree-granting institutions were enrolled in private, non-profit schools and about 2 percent were in private, for-profit schools. Of those students enrolled in non-degree-granting institutions, 48 percent were enrolled in private, for-profit institutions.

About 3 percent of students enrolled in eligible postsecondary institutions were nonresident aliens (individuals who are in the United States on temporary visas). Of the citizens and permanent residents enrolled in eligible postsecondary institutions, 72.8 percent were white, 11.3 percent were black, non-Hispanic, 8.8 percent were Hispanic, 6.1 percent were Asian/Pacific Islander and 1.0 percent were American Indian/Alaskan Native. As shown by the racial-ethnic distribution of U.S. citizens and resident aliens in table B, minority<sup>4</sup> students represented a higher proportion of the enrollment at non-degree-granting postsecondary institutions than at degree-granting institutions.

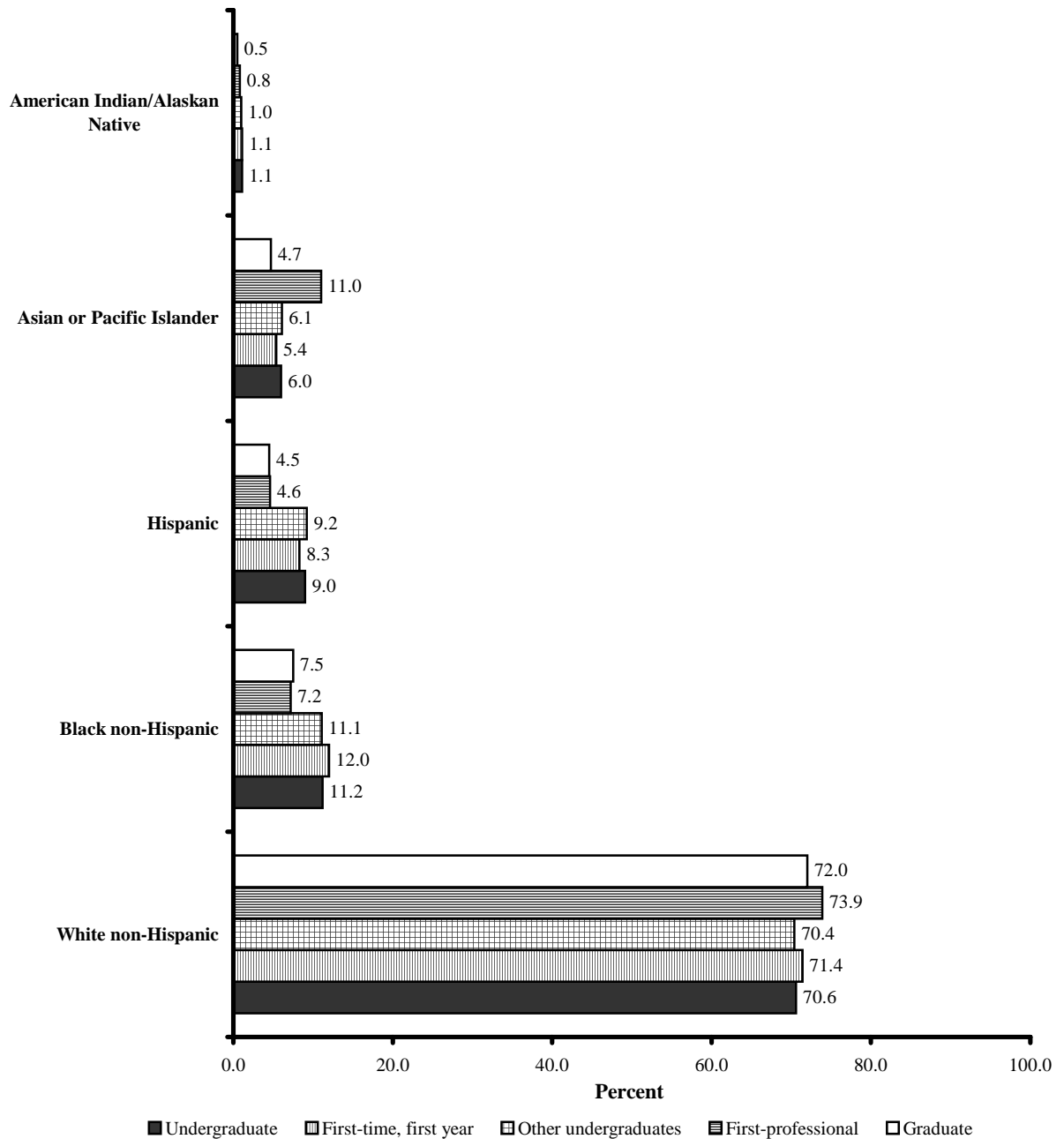

The distribution of students by racial-ethnic background varied considerably by level, participation status and type of institution. For example, blacks, Hispanics, and American Indian/Alaskan Natives comprised a higher percentage of undergraduate enrollment than graduate or first-professional enrollments. Further, a higher percentage of blacks, whites, and American Indian/Alaskan Natives were enrolled as first-year, first-time students than at the total undergraduate level (figure A). Asian/Pacific Islanders, on the other hand, comprised 11.0 percent of all first-professional students, but only 6.0 percent of undergraduate and 4.7 percent of graduate students.

In 1997, a larger percent of all students in degree-granting institutions (55.9 percent) were women. Similarly, the majority of undergraduate (56.1 percent) and graduate (56.8 percent) students were women (table C). However, women made up only 43.1 percent of first-professional students. Within each of the racial-ethnic groups, women composed the majority of undergraduates as well as first-time, first-year undergraduates. Similarly, at the postbaccalaureate level, women made up over half of the graduate students in each racial-ethnic category although Asian women were a bare majority comprising 50.7 percent of all Asian graduate students. It is also notable that more than two-thirds of all black graduate students were women. However, the first-professional level, the picture is quite different for all racial-ethnic groups except blacks. While women accounted for just 41.4 percent of white first-professional students, 46.5 percent of Asian students, 44.9 of Hispanic students, and 46.2 percent of American Indians, they accounted for 56.9 percent of black first-professional students.

Most students (58.2 percent) were enrolled on a full-time basis (table D). Hispanic students, however, were more likely to enroll part-time than whites or other minorities. About half (49.6 percent) of all Hispanic students attended school part-time. However, at the first-professional and graduate levels, Hispanic students were more likely to enroll on a full-time basis than black or white students. Asian or Pacific Islanders were more likely than all other students to attend full time at both the undergraduate (61.0 percent) and graduate levels (51.0 percent).

Hispanics and American Indian/Alaskan Natives were a smaller percentage of 4-year college enrollment and a larger percentage of 2-year college enrollment than might be expected from the overall distribution of enrolled students by race-ethnicity (tables 5 and 6)<sup>5</sup>. Additionally, blacks and Hispanics made up almost 30 percent of the total enrollment in for-profit, eligible, degree-granting institutions compared with about 15 percent of the enrollment in private, non-profit institutions and 20 percent of the enrollment in public institutions (table 4). Although non-degree-granting institutions enrolled only 2.7 percent of all students attending eligible postsecondary institutions, they enrolled a higher percentage of black (4.9 percent) and Hispanic (4.5 percent) students (table 1).

Median age in table E shows that in addition to undergraduates being youngest overall, first-professional students are younger than graduate students. Indeed, in fall 1997, 64 percent of undergraduates were under 25 with a median age of 21.8 years. This compares with 37.3 percent of first-professional students who were under 25 and whose median age was 26.2 years and 15.3 percent of graduate students who were under 25 years of age and whose median age was 30.6 years.

Among undergraduate students, full-time students were significantly younger than part-time students. About 82 percent of full-time undergraduates were under 25 compared with 38 percent of part-time undergraduates and, there was a differential in median age of almost 8 years between full-time and part-time undergraduates. The median age of a full time undergraduate in 1997 was 20.4 years while the median age of a part-time undergraduate was 28.0 years.

Women undergraduates, overall, were slightly older than men undergraduates by about half a year, on average. The greatest difference in age between men and women undergraduates was evidenced among part-time students, with women being approximately two years older than their male counterparts. Interestingly, women first-professional students were slightly younger (median age was 25.6 years), on average than their male counterparts (median age was 26.5 years), while women graduate students were slightly older (median age was 30.9 years) than men graduate students (median age was 30.2 years).

Data from fall 1997 enrollment tend to confirm the notion that 2-year institutions serve an older population than 4-year schools. The median age of 4-year undergraduates in 1997 was 21 years, while the median age of 2-year college students was 24 years.

## **Changes in Enrollment between 1996 and 1997**

Between 1996 and 1997, enrollment in higher education institutions increased by 0.9 percent. This change is driven almost entirely by an increase in the number of full-time students. When broken down by race and ethnicity, the increase is largely due to a change in minority enrollments. There was no measurable change in the number of white students or the number of part-time students, and the number of non-resident aliens decreased by less than .3 percent. The numbers of both men and women increased but women had a higher percentage increase than men (a 1.1 percent increase vs. a .7 percent increase) (tables F and G).

This general pattern of change was somewhat different in each institutional sector. Enrollments increased in 4-year public institutions by .5 percent although there were decreases in the numbers of whites, males, and part-time students and increases in the numbers of all other students. In 4-year private institutions enrollments of all types of students increased although the percentage increase in 4-year private for-profit institutions was substantially higher than in private non-profit institutions. The overall increase in enrollment in 4-year private non-profit institutions was 1.3 percent while the overall increase in 4-year private for-profit institutions was 18.7 percent.

Overall, there was also an increase in the numbers of students attending 2-year institutions due totally to increases at public 2-year institutions. In private non-profit and private for-profit 2-year institutions, total enrollment declined between 1996 and 1997. The number of white students and non-resident aliens declined overall, while the numbers of all other students increased. In private non-profit institutions, smaller numbers of white, black, Hispanic, American Indians, and non-resident aliens resulted in an overall 4.8 percent decrease in the number of students enrolled. In private for-profit institutions, decreases in the numbers of whites, Asian or Pacific Islanders and American Indians/Alaskan Natives were largely offset by increases in the numbers of blacks and Hispanics, and a 50 percent increase in non-resident aliens enrollment.

The increase in enrollment between 1996 and 1997 occurred at undergraduate and graduate student levels although at different rates. Undergraduate enrollment increased by 1.0 percent (table 21), graduate enrollment increased by .6 percent (table 23), while enrollment in first-professional schools did not change (table 22). Among undergraduates, there were increased numbers of men and women, full- and part-time students, and U.S. citizens and resident aliens (all races) although there were substantial differences in the rates of increases. Only the number of non-resident aliens decreased.

The overall static level of enrollment in first-professional schools does not reflect the detailed changes (table 22). The number of whites, blacks, and Hispanics decreased while the number of Asian/Pacific Islanders and American Indian/Alaskan Natives increased. The number of women enrolled at the first-professional level increased by 2.4 percent while the number of men decreased by 1.8 percent. Additionally, while first-professional enrollments in public institutions went up, they went down in both private non-profit and private for-profit institutions.

At the graduate level (table 23), minorities, non-resident aliens and women increased their share of graduate enrollment between 1996 and 1997. Even so, minorities comprised only 17 percent of the graduate student enrollment compared to their 27 percent share of undergraduate enrollment.

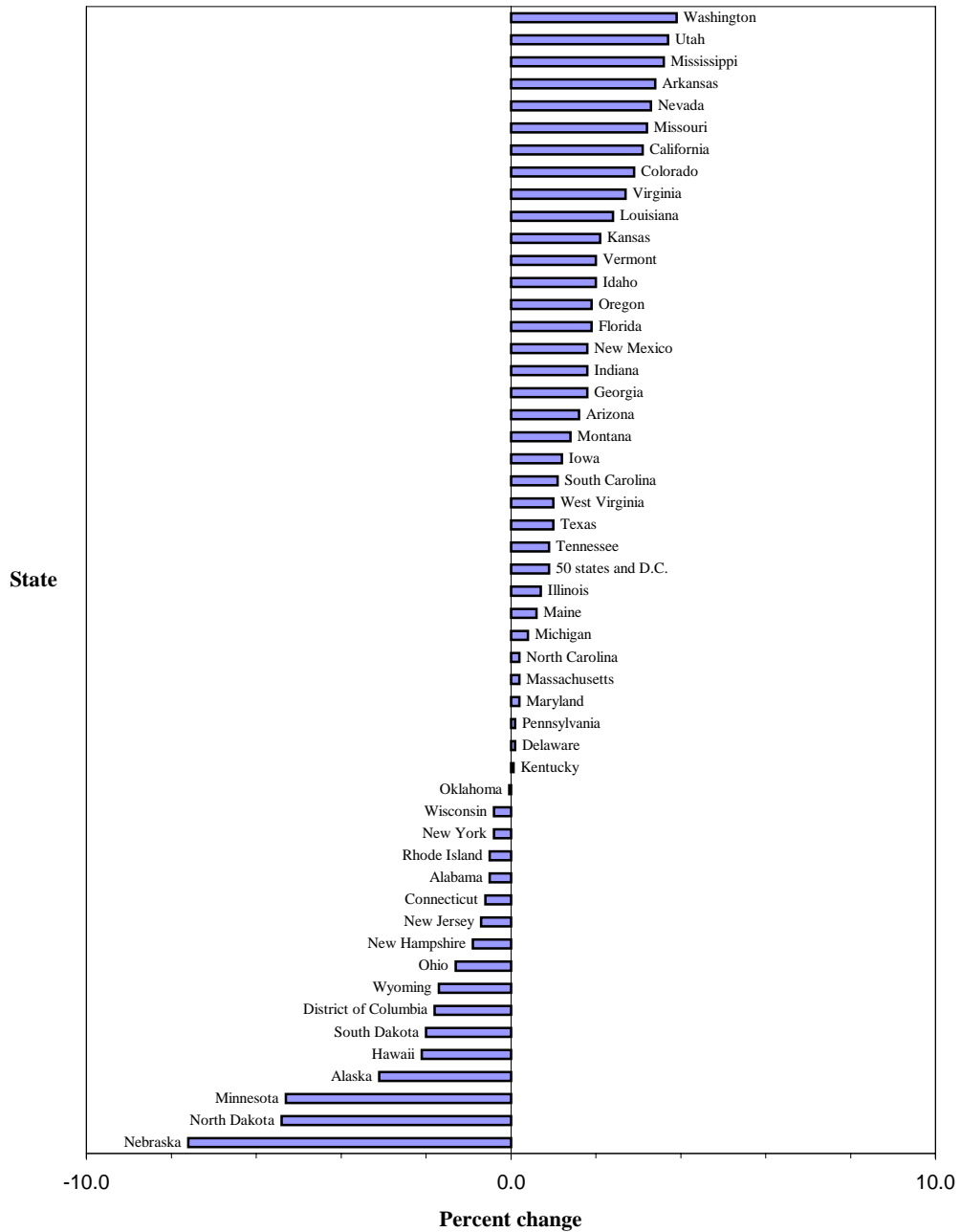
## **Enrollments by State**

The distribution of minority enrollment by state largely reflects the distribution of minority residents within each state. To illustrate, in 1997, states differed greatly in the distribution of minority and white students. For example, in California less than half of the students enrolled in its colleges and universities were white, while blacks, who represent 10.7 percent of enrollments nationally, composed only 7.8 percent of California's enrollment (table 25). By comparison, Hispanics made up 20.7 percent of California's enrollment, and Asian or Pacific Islanders 17.8 percent. Conversely, in Alabama, the District of Columbia, Georgia, Louisiana, Maryland, Mississippi, and South Carolina, blacks' share of enrollment ranged from 22.6 to 31.0 percent, which was more than double their national enrollment share. In New Mexico and Texas, Hispanics composed 33.6 and 21.7 percent of total enrollment, respectively, compared with their 8.4 percent share of enrollment in the nation as a whole. In Hawaii, Asian/Pacific Islanders composed 60.7 percent of total enrollment, while in Alaska, Arizona, Montana, New Mexico, North Dakota, Oklahoma, and South Dakota, American Indians/Alaskan Natives had a significant share of total enrollment (4.0 percent to 11.2 percent) compared with 1.0 percent nationally.

While there was very little change in enrollment between 1996 and 1997 (.9 percent increase), sixteen states and the District of Columbia experienced decreases in enrollment (figure B). Nebraska had the largest percentage decrease (7.6 percent), while Minnesota and North Dakota experienced declines in enrollment of over 5 percent. Washington state posted the largest percentage increase in enrollment (3.9 percent) followed by Utah (3.7 percent), Mississippi (3.6 percent), Arkansas (3.4 percent), Nevada (3.3 percent), Missouri (3.2 percent) and California (3.1 percent).

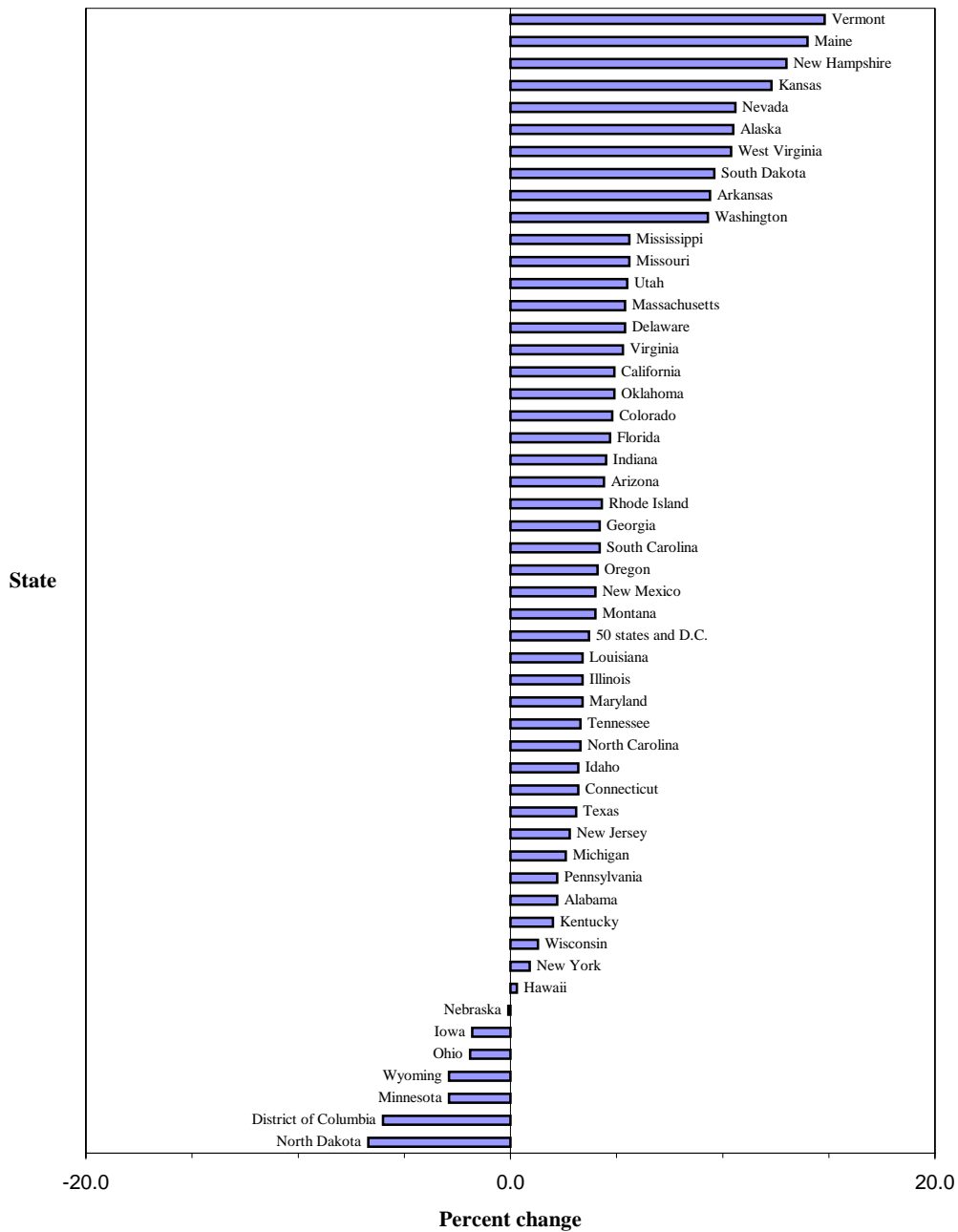
Six of the states that had a decline in total enrollment between 1996 and 1997 also had a decrease in the number of minority students enrolled in institutions in their states (figure C), and one state with an overall increase had a decrease in minority enrollment (Iowa). In most states, however, the percentage increase in minority enrollment was much greater than the percentage increase in total enrollment. For example, Arkansas had a 3.4 percent increase in total enrollment and 9.4 percent increase in minority enrollment.

## Technical Notes

### Data Sources

The enrollment statistics in this report are derived from information reported by postsecondary institutions through the Integrated Postsecondary Education Data System (IPEDS) "Fall Enrollment" surveys 1996 and 1997. The major emphasis of this report is based on the subset of postsecondary institutions referred to as degree-granting institutions that are eligible for Title IV federal financial aid. Title IV eligible institutions that do not award degrees are referred to as "non-degree-granting institutions." This report includes only those institutions in the 50 states and the District of Columbia.

### Survey Methodology

#### Overview

The Fall Enrollment (EF) survey is conducted annually as part of the National Center for Education Statistics' Integrated Postsecondary Education Data System (IPEDS).<sup>1</sup> The EF survey collects data on the number of students enrolled in postsecondary institutions<sup>2</sup> that were eligible to participate in Title IV federal financial aid programs in the United States and its outlying areas<sup>3</sup>. Eligibility status of institutions was obtained from the Office of Postsecondary Education's March 1997 Postsecondary Education Participants System (PEPS) file.

Students **included** in the Fall Enrollment survey:

- students enrolled in courses creditable toward a degree or other formal award;
- students enrolled in courses that are part of a vocational or occupational program, including those enrolled in off-campus centers; and
- high school students taking regular college courses for credit.

Students **excluded** from the Fall Enrollment survey:

- students enrolled exclusively in courses not creditable toward a formal award and who are not in a postsecondary vocational program;

- students enrolled exclusively in remedial courses;
- students exclusively auditing classes;
- students studying abroad (e.g., at a foreign university) if their enrollment at the institution is only an administrative record and the fee is only nominal;
- students in any branch campus located in a foreign country; and
- students earning continuing education units (CEU's) only.

There are two versions of the Fall Enrollment survey. The most extensive form, "EF1", was sent to all 4-year institutions. The "EF2" form is less detailed and was sent to 2-year postsecondary institutions that grant an associate's degree (degree-granting). Additional enrollment data was collected on the "Consolidated" survey (CN), which was sent to 2-year institutions that grant awards or certificates of at least 2 but less than 4 academic years (non-degree-granting) and less-than-2-year institutions that offer awards or certificates of less than 2 years duration<sup>4</sup>. The enrollment data collected via the Consolidated survey are integrated into the Fall Enrollment database. The data requested on each form or survey varies as follows:

### **Universe, Institutions Surveyed and Response Rates**

A major subset of all postsecondary institutions, are those institutions that are eligible to participate in Title IV federal financial aid programs. It is this group of institutions that annually receive a fall enrollment survey. Beginning with the 1996 IPEDS, the subset of eligible institutions was validated by matching the IPEDS universe with the PEPS file, which is maintained by the Office of Postsecondary Education (OPE). OPE grants eligibility to institutions to participate in Title IV federal financial programs. This validation process was repeated for the 1997 IPEDS for determining eligibility, and 6,810 eligible institutions were mailed Fall Enrollment or Consolidated Survey forms.

Survey forms were mailed in July 1997: (1) EF1 forms were mailed to 2,365 institutions; (2) EF2 forms to 1,772 institutions; and (3) CN surveys to 2,673 institutions. The survey results were collected from November 1997 through June 1998. During this time period a total of 175 institutions were deleted from the universe. These deletions resulted from formal notification by IPEDS state coordinators, the Department of Education eligibility notices, and from follow-up telephone calls. Included in the deletions were: (1) duplicates of other institutions on the file; (2) institutions that closed or had merged with another institution, and thus were no longer a legitimate institution or branch; (3) institutions that no longer offered postsecondary programs; or (4) schools that did not conform to the IPEDS definition of an institution or branch. At the conclusion of this process, 6,635 institutions represented the final 1997 fall enrollment universe. The final universe was also adjusted to reflect institutions that changed from one sector to another subsequent to survey mailout.

Table H shows the number of institutions that were mailed the 1997 Fall Enrollment survey (or the Consolidated form) by level and control of institution; the final in-scope universe of institutions receiving either survey form; the number of in-scope institutions that responded; and the response rates.

On the 1997 IPEDS files, institutions are identified as (1) degree-granting - those that offer either an associate's, bachelor's, master's, doctor's, or first-professional degree; and (2) non-degree-granting (certificate only) - those institutions that offer only certificates at any level. Institutions offering only postbaccalaureate, post-master's, or first-professional certificates and institutions offering certificates of less-than-4-years are included in this group.

Table I provides the number of institutions and survey response rates by eligibility status and degree-granting status by control and level of institution. The institution's eligibility status was updated in March of 1998 and 246 institutions that were sent a fall enrollment or consolidated survey lost eligibility status. There are 6,389 eligible institutions on the file; of these, 4,074 are degree-granting.

## Survey Conduct and Editing

The 1997 Fall Enrollment survey was due November 15. Survey data were collected via paper or transmitted to NCES via the Internet. Some institutions did submit data on diskette. Data for nonresponding CN institutions were collected through the Postsecondary Education Telephone System (PETS). All data, whether received on paper forms, diskettes, electronically via the Internet, or through the PETS system, went through the same editing process. Extensive follow-up for survey nonresponse was conducted from November 1997 through April 1998. Initially, reminder letters were mailed, encouraging nonresponding institutions to complete and return their forms; and subsequently, the PETS was used to collect critical data by telephone from an institutional representative.

Survey responses were edited for internal and inter-year consistency. The following editing procedures were used:

### Part A: Enrollment by sex and race-ethnicity

- (1) Addition checks were performed by adding down the columns and comparing generated totals with reported totals. If the reported total differed from the generated total but was within a designated range, the reported total was replaced by the generated total and the cell was flagged with the proper impute code. If the difference exceeded the designated range, institutions were contacted for verification/correction. Addition checks were also performed by generating totals for men and women by adding across columns (racial-ethnic group) in each line. Generated totals by sex were compared to the reported totals. If they differed but were within a designated range a balance field was created containing the difference by sex and placed on the data file. Reported detail and totals were not altered. If the difference exceeded the designated range, institutions were contacted for correction. Editing of the racial-ethnic data is explained in detail in the section on raking of racial-ethnic data.
- (2) Comparisons were also made with the number of students reported for selected items for the prior year. If the differences were sufficiently large to trigger an edit flag, institutions were contacted for verification.

### Part B: Enrollment by Age

- (1) Part B data were edited in a similar manner. Addition checks were performed by comparing reported totals in Part B to corresponding totals in Part A. Differences between the totals were calculated and balances containing the differences were generated. If the balance was outside a certain range the institution was contacted for verification/correction. If the balance was within a certain range, the Part B total was replaced by the corresponding total from Part A. The balance was then allocated among the age categories using the institution's reported age distribution.

## **Data Management and Imputation**

Data for Part A, enrollment by race-ethnicity, were imputed for nonresponding institutions. The following imputation procedures were used:

For institutions with reported data on the prior year enrollment file: all institutions that reported data in both 1996 and 1997 were grouped by level of offering and control of institution. Enrollment data were then aggregated for each group and percent changes were calculated. For each nonresponding institution in 1997, their 1996 enrollment data were adjusted by the percent change of the group to which that institution belonged.

For institutions with no prior year report, imputations were based on current year group means or ratios derived for similar institutions with reported data in 1997. Groups were formed by combining institutions by level of offering and control of institution.

## **Raking of Racial-Ethnic Data**

When data were reported by racial-ethnic categories on a detail line and the generated sum of these enrollments did not equal the reported total enrollment, the difference between the generated total and the reported total was calculated. If the difference exceeded a certain designated range the institution was contacted for correction. If the difference was within the designated range, a "balance column" was created. The balance was then distributed in the same proportions as the reported racial-ethnic data for that detail line. If there were no racial-ethnic data reported for any detail lines, but racial-ethnic data were reported for the subtotal lines (8=undergraduate full-time, 14=postbaccalaureate full-time, 22=undergraduate part-time and 28=postbaccalaureate part-time), the total from columns 15 and 16 (male, female ) of each detail line were distributed in the same proportions as the racial-ethnic enrollments reported on the corresponding subtotal line. If the institution did not report racial-ethnic data on the subtotal lines, but reported racial-ethnic data on the grand total line (29), then line 29 was used to distribute the data on the detail lines. If the institution only reported data in columns 15 and 16 on all lines, data were distributed among racial-ethnic categories based on the distribution of totals of the imputation group in which the institution was a member. Groups were formed by aggregating lines 8, 14, 22, and 28 by survey form, control, and state by sex.

Beginning in 1990, a "race-ethnicity unknown category" was incorporated into the Fall Enrollment survey. To allow for analysis of enrollment trends by race-ethnicity, enrollment reported in the race-ethnicity unknown category was raked across those columns that represent U.S. citizens, that is, columns 3 through 12; race unknown was not distributed to nonresident aliens. The procedure used to distribute the race unknown category among the race-ethnic categories was the same procedure used for distributing the balance columns. Note that raking may be done on data that are imputed as well as the reported data. Table J contains the enrollment numbers by "race-ethnicity unknown" and balance categories.
